Dear SitePoint:

I wish to draw to your attention a listing, contest or item which I allege infringes the rights of a third party and to request its removal from the SitePoint website.

I state **UNDER OATH and acknowledging that any false oath may be subject to PENALTY FOR PERJURY** that:

4. Unless the Infringing Item is removed from the SitePoint website, the IP Owner will continue to suffer loss or damage or devaluation of the IP Rights;
5. The IP Owner can provide proof that the IP Owner is the owner or licensee of the IP Rights;
